Product name:

PintaPolar Top Coal Grey 10x1 m

Product description and identification:

The declared product is used as a upper layer in a two-layer waterproofing system from BMI, marketed under the brand Icopal, made for roofs with particularly high demands on the waterproofing layer. The system consists of an upper layer (Top) and an under layer (Underlay), both based on SBS-modified bitumen. SBS increases the elasticity of the waterproofing layer and provides increased joint strength and service life. Two separate waterproofing layers provide a good protection against leakage. The under layer can also be used as a temporary seal while the rest of the roof is completed.

Two-layer waterproofing systems are defined in the product standard EN 13707 Flexible sheets for waterproofing.

The layers are either welded or glued with liquid bitumen into the substrate. In this EPD it has been assumed that the product is fully welded. The declared product is expected to fulfil it's function for 50 years.

All (known) input flows (e.g. raw materials, transportation, energy use, packaging, etc.) and output flows (e.g. emissions to soil, air and water, construction waste, packaging waste, end-of-life waste, etc.) related to the building fabric are considered in this LCA. The total neglected input flows do therefore not exceed the limit of 5% of energy use and mass.





• End of life stage (C1-C4)

All input flows (e.g. energy use for demolition or disassembly, transport to waste processing, etc.) and output flows (e.g. end-of-life waste processing of the product, etc.) are considered in this LCA. The total neglected input flows do therefore not exceed the limit of 5% of energy use and mass.


